STRATEGIC IMPLEMENTATION PROGRAMME

One of the over-riding aims of the Strategic Implementation Programme is to influence the service plans of other agencies, in particular New Forest District and Hampshire County Councils. The townspeople's views and feelings may be incorporated into the Local Development Framework. These key issues have been identified through local consultation and analysis, and this programme lists a number of measures which will help address the problems. Whilst different projects will require different agencies/organisations to be the lead, the organisation that will facilitate or promote the process is Ringwood Town Council (**RTC**). A number of potential partners have been proposed, since it is most likely that they are the appropriate agency to assist in the achievement of the aims of the Plan and indeed, where required, to lead. It must be noted that, at this time, this can in no way commit the organisations listed to taking these measures, as discussions need to be held with each of them on the projects in terms of feasibility and resources.

STRATEGIC IMPLEMENTATION PROGRAMME PRIORITIES

:

- **THE ENVIRONMENT:-** The beautiful areas surrounding Ringwood are highly valued by the community and feature most strongly on the list of things that people like most about living in the area. To help protect this, people have clearly expressed the view that future necessary development should be very carefully managed, both with regard to position and quality of design. There is a need to improve the appearance of the Town, both in terms of the built and natural environment, and to create more green open space. There should be more access to the River Avon from the town - at present this is a wasted resource. There is a need to address the unacceptable behaviour that leads to excess litter, graffiti and dog waste spoiling the local environment. Risk of flooding needs to be assessed and addressed on an on-going basis.

ECONOMY:- Ringwood has a diverse mix of businesses spread throughout the town and over nine industrial estates. Some businesses are experiencing difficulties because they wish to expand but there is no land available. Salaries are generally low. There is a need to encourage high tech business into the area and provide opportunities for land use that allow existing businesses to expand and provide employment opportunities, rather than lose potential employment to other areas. Any new building should incorporate the necessary infrastructure, including that for upgrading to the fastest speed of internet. Ringwood boasts a good variety of independent shops with some nationals. The recently built Furlong Centre has attracted more ‘up market’ shops and they attract customers from far and wide. However, some independent retailers need to address the challenges of the internet and embrace its opportunities in order to compete. There is an active Chamber of Commerce which could help address some of these issues.

TRANSPORT AND ACCESSIBILITY:- The A31, whilst being Ringwood’s lifeline, also brings traffic misery. The road is already operating close to capacity with long tailbacks in both directions at peak times and on weekends. It is a source of both air and noise pollution. Congestion in the town is another problem with illegal parking in the High Street adding to the difficulties. The proposal for a relief road needs to be studied in earnest along with an appraisal of the exits onto the A31, whilst also considering pedestrianisation of the High Street and Market Place. There is also insufficient long stay car parking which means that the verges on the approaches into the town are littered with cars. Public transport is expensive and unreliable. There is no public transport into the neighbouring towns in the evenings and young people in particular are barred from opportunity if they cannot drive. There is a need to match the availability and cost of public transport services with the wide range of community needs in Ringwood.
