#### OS/5946 PUBLIC PARTICIPATION

There were five members of the public present, four of whom were interested in items on the agenda.

A resident reported on the parking situation in the vicinity of the Bickerley and indicated that this was not permitted use of the Village Green under the agreed covenants, included in the contract of sale this is not a permitted use within the laws of a Village Green, or the agreed covenant, as stated in the contract of sale and the title deeds at the date of the Council's purchase(*amended OS/5958 refers*). He requested that the matter be looked in to and brought before the relevant Committee as soon as possible.

## OS/5951 TREE PLANTING

Members considered Cllr Deboos' report on tree planting and the issues for decision therein (*Annex A*).

He explained that this proposal had been referred from the Ringwood Environmental Action Leadership (REAL) Working Party as part of the RACE project to plant 20,000 trees in and around Ringwood in 2020. It was hoped that in addition to the Council agreeing to the planting of trees on its land, other landowners would come forward and offer sites, along with schools and other groups.

Cllr Deboos clarified (para 2.2) that the planting of 5,000 trees, as requested, would correspond to around 1,000 meters of hedging, in addition to the 840 saplings already approved. The first major planting of saplings (420) is due to take place on Sunday 16<sup>th</sup> February at Poulner Lakes between 11am and 3pm.

He proposed an amendment to recommendation 3.2. In addition to the planting to the east of Southampton Road (Figure 3), Transition Ringwood (TR) wished to plant on the west side of the road. Approval by the Council would enable TR to make an application to the Woodland Trust for a free sapling pack.

The Committee was in support of the proposals, as amended, and wished to congratulate the members of the REAL Working Party and the volunteers for their work in progressing this project.

**RESOLVED**: 1) That the Council supports the planting of a target of 5,000 trees/hedging during 2020 by the Council and RACE on Council land, on condition that they are cared for by RACE for two years after planting, subject to suitable sites being found; and

2) That the Council approve the planting of saplings at Poulner Lakes and the east and west side of Southampton Road, as shown in the Figures, totalling around 2,100 or so (with the siting and exact nature of subsequent plantings to be proposed by RACE via REAL WP, in conjunction with the Town Clerk and Grounds Foreman, and considered by this Committee at a later date).

#### Tree-planting

- 1. Introduction and reason for report
  - 1.1 The proposals in this report come from the 'Trees for the Future' Ringwood Action on the Climate Emergency (RACE) team via the REAL Working Party.
  - 1.2 This Committee has already sanctioned the planting of 840 saplings on Council land, 420 as a connective group at Poulner Lakes and 420 free from the Woodland Trust for delivery in the Autumn and the siting is to be agreed.
  - 1.3 It is proposed that this Committee approves the planting of a total of 5,000 trees in 2020 on Council land, which would be a combination of Council and RACE sourced saplings.
  - 1.4 Some sites are proposed for a proportion of the 5,000 trees.
  - 1.5 Environmental benefits for the community include sequestration of CO<sub>2</sub>, prevention of soil erosion, adsorption of particulate pollutants to improve air quality, the creation of wildlife food sources and corridors and potential reduction in road noise for plantings close to roads. There are also many social benefits.

#### 2. Background information and options




Figure 1 – Connective group planting at Poulner Lakes

- 2.1 The 420 saplings paid for by a kind donation of £400 by the Council are scheduled for planting on the 16<sup>th</sup> February 2020, weather permitting. The scheme for this is shown in Figure 1 below.
- 2.2 The planting of a total of 5,000 trees would correspond to around 1,000 meters of hedge in addition to the 840 saplings already approved.
- 2.3 A number of sites for hedging have been identified as suitable in conjunction with the Council's Grounds Foreman, two of which are described in detail here. The first, at Poulner Lakes, involves planting a hedge adjacent to the otter-proof fence between Council land and Northfield Lake, which would improve the visual amenity of the area. The scheme for this is shown in Figure 2 below. It is proposed that the Council apply for one of the free Autumn Woodland Trust 420 sapling hedge packs for this site, which would plant 100m. As the length of the site is well over 200m, it is proposed that RACE plant 100m or so of hedge in the Spring and/or Autumn at their expense.





Figure 3 – Proposed road-screening planting at Southampton Road

- 2.4 The second site, by Southampton Road, would see the planting of a screening hedge along the fence by the A31. The hedging trees will give improved visual amenity, from blossom and berries, food and shelter for wildlife and some improvement to air quality. By 'scalloping' the hedge, small areas would be created for wild flower planting to be carried out by Transition Ringwood in agreement with Council grounds staff. The scheme for this is shown in Figure 3 below. It is proposed that RACE apply for one of the free Autumn Woodland Trust 420 sapling hedge packs for this site supplemented by additional saplings as required funded and supplied by RACE.
- 2.5 Although other sites for hedges and a small number of conventional tree plantings have also been identified, RACE does not yet have the funding to support a formal proposal to this Committee. Sites include the other side of Southampton Road (see Annexe C map), Ash Grove play area (to screen from the planned new development) and a site to the south of Poulner Junior School.
- 2.6 In the first year, 5,000 saplings would be expected to sequester about 0.5 tonne of CO<sub>2</sub>, equivalent to the offsetting of Carvers Footway lighting annual electricity use. At maturity, the annual sequestration rate would be expected to be over 50



tonnes of CO<sub>2</sub>, equivalent to the amount generated by Council electricity use at the Gateway and Carvers Clubhouse combined.

- 2.7 The RACE charity would care for the saplings for the first two years after planting to allow them to establish. Thereafter, Council grounds staff would maintain the trees. There will be no direct financial cost to the Council.
- 3. Issues for decision and any recommendations
  - 3.1 Whether to support the planting of a target of 5,000 trees during 2020 by the Council and RACE on Council land, on condition that they are cared for by RACE for two years after planting.
  - 3.2 Whether to approve the planting of saplings at Poulner Lakes and Southampton Road as shown in the Figures, totalling around 1,700 or so (with the siting and exact nature of subsequent plantings to be proposed by RACE via REAL WP, in conjunction with the Town Clerk and Grounds Foreman, and considered by this Committee at a later date).
