PLANNING APPLICATIONS

With the agreement of Members, application 18/11648 Land at Crow Arch Lane and Crow Lane was brought forward, for the benefit of the applicant's representative who was present.

18/11648 – Land at Crow Lane and Crow Lane

Robin Pearmain, Senior Planning Manager, Linden Homes gave a progress report on Phase 1 and 2/3 in terms of construction and occupancy and presented a new application for an additional 24 dwellings (3 pairs of semi-detached houses, 4 terraces of 3 houses, 1 block of 6 flats), on the site, to the south of the Castleman Trailway. This would increase the total number of properties on the whole site from 175 to 199.

The construction of 10 dwellings, in this area, had been approved as part of the Phase 2/3 application (17/11358) and this application would increase the number of dwellings to 34. There were concerns that the significant increase in the number of dwellings proposed would be overdevelopment of the site, increasing the amount of traffic on Crow Arch Lane and affecting the existing properties.

There was a discussion in relation to density and viability of the site for the developer. The possibility of achieving a design with more affordable open market homes and less density was questioned. Mr Pearmain indicated that in a semi-urban site the aim should be at least 30 dwellings per hectare and, looking at this site as a whole, and taking into consideration the green space, parking, gardens and landscaping, he indicated that there would be a pleasant, spacious feel and the properties would not look crammed in. He said that this application replicated Phase 1 and 2/3 and respected the existing housing.

Members highlighted that the application to amend Phase 2/3 was justified at the time by the applicant as a response to local demand for cheaper open market housing. They were disappointed that this application proposed that the 50% of properties, to be sold on the open market, were the larger 3 and 4 bedroom properties and this did not assist people wishing to get on the housing ladder. A mix of the 2 and 3 bedroom houses would be shared ownership properties, but there was some disappointment that the 1 and 2 bedroom properties would not be available on the open market.

Members were concerned that Crow Arch Lane retains its integrity as a lane and that it would be unsuitable for construction traffic to use it to access the site. Members felt it important to clarify this issue, at this stage, so that it can be considered as part of the planning application. Mr Pearmain indicated that a temporary access could be installed over the Castleman Trailway for this purpose and an updated construction method statement would be provided for the next meeting.

There was concern in relation to infiltration of water and drainage, as recently there had been some flooding on the SANGS, where it is thought construction vehicles may have compacted the area. It was suggested that this would negate the infiltration tests undertaken.

A travel plan would be provided by the applicant with provision for non-car based journeys. Members highlighted safety concerns with the use of Crow Arch Lane by pedestrians or cyclists as it is a narrow, single track lane with no pavement.

It was noted that there were no comments available from NFDC in relation to design, density and open space requirements, although Mr Pearmain indicated that the open space standard had been met and that this was confirmed by NFDC at the pre-

application stage. In addition, no comment had yet been submitted by the Highways Officer. In light of the outstanding information, it was agreed that this matter be deferred until the next meeting on 1st February 2019.

The remaining applications were dealt with in list order.

18/11675 – 14, Fieldway – Although it was not a declarable pecuniary interest, Cllr Ward wished to make Members aware that he knew the applicant.

P/5567 FLOOD ACTION WORKING PARTY

Members considered the notes of the Flood Action Working Party held on 11th December 2018 (Annex B).

In relation to the culvert at the northern entrance to the Linden Homes site (4i), HCC officers will meet to resolve the issue of access to the chamber between the 900mm and 525mm pipes, for the purpose of jetting. Linden Homes had installed a man-hole cover, but had apparently removed it on the instruction of HCC. HCC will not adopt the road in its current state, as there is no way of removing blockages.

The Deputy Town Clerk reported that she had raised concerns to NFDC in relation to flooding of SANGS on the Linden Homes site (4ii). If the infiltration ability had been compromised by compacting of the area, during construction, this could be a breach of planning conditions.

HCC officers have conflicting views on how to make progress with the installation of the non-return valve in the area of Crow wetland (5i) and bringing the Moortown Lane Flood relief drain back in to use. A meeting was planned and an update would be provided at the February meeting.

Cllr Wiseman reported in relation to Crow Hill drainage (6) that the ditch had not yet been cleared.

Members commented on their concern that matters were ongoing and not resolved.

RESOLVED: That the notes of the Flood Action Working Party on 11th December 2018 be received and the proposals therein be approved (*Annex B*).

HAMPSHIRE COUNTY COUNCIL RIGHTS OF WAY CUTTING LIST - 2019

Members considered the request from HCC to reduce the number of rights of way on its cutting list for 2019 (*Annex C*). The Ringwood and Fordingbridge Footpath Society had been consulted and raised concerns with the proposal to reduce the number of paths to be cut to 5 (the parish of Ringwood has 86 rights of way).

It proposed that all of the paths should remain on the cutting list, particularly as they are relatively short sections and only a very small proportion of the total number of paths in Ringwood and be given the priority detailed in paragraph 5 of the report.

It was noted that the Town Council will work with the Footpath Society to clear Footpath 42 of small trees and shrubs currently encroaching on the path.

Cllr Wiseman reported that she had encountered difficulties when walking Footpath 52(Hampshire Hatches Lane) as there were some obstructions blocking the path and requested that this be looked at.

The Deputy Town Clerk confirmed that the path between The Quomp and Woodstock Lane had recently been cleared by the grounds team under the Lengthsman Scheme.

RESOLVED: That the Footpath Society's recommendations for HCC Rights of Way Cutting List 2019, as outlined in paragraph 5 of the report, be approved.

P/5571 PROJECT OVERSIGHT AND BUDGET 2019/20

The Deputy Town Clerk highlighted a change to the current project report with the costs heading now providing a better indication of the source of funding.

A4 Human Sundial / C2 A31 Improvement Scheme – The Deputy Town Clerk had asked HCC to provide details of the officer assigned to the project and U+I for an update on the old Town Hall (and other buildings) and was awaiting a response. It was noted that the outcome of the bid for Highways England funding for town centre improvements would be known shortly. Central government had recently announced significant funds were to be made available for this purpose also and the Chairman was keen that the Council consider making a submission. When further details are available a meeting of the Town Centre Working Party will be arranged to receive the updates and consider the opportunities available.

C1 Pedestrian Crossings Christchurch Road – There were some issues with the design stage and HCC had indicated that it may not be possible for works to start, until the A338 roadworks are completed. More traffic is using Christchurch Road as an alternative and this scheme may involve a road closure, or if not, traffic lights. Members had concerns with the additional delay and that the developers contributions allocated to this project were at risk.

Members gave further consideration to the inclusion and prioritisation of new projects in the Committee's budget for 2019/20 (Annex F) and confirmed the position without change.



1. Apologies

There were none.

2. Declarations of Interest

There were none.

3. Notes of Last Meeting

The notes of the last meeting held on 28 September 2017 were agreed as a true record.

4. Crow Lane Ditch

i) Culvert at northern entrance to Linden Homes site off Crow Lane

There were concerns that the replacement of the one 900mm pipe with 2 x 525mm pipes had led to a reduction in capacity of over 30% and, due to the lack of fall to aid the flow rate, it was expected that this would lead to increased flooding in the area of the Elm Tree. In addition, the new pipes had been sunk 9 inches below the bottom of the stream bed, which would cause the culvert to silt up on a regular basis. PS said that the original planning consent stated there should be no interference with the flow and profile of the ditch, and in his view, this requirement had not been met and the two smaller pipes should be removed to restore capacity. VW explained that the plans had been through the Ordinary Watercourse Consent process and had been signed off by HCC, and NFDC had confirmed it was satisfied that the appropriate planning conditions had been met. Therefore, the pipes would remain in place.

At the meeting on 18 October 2018 with NFDC and Linden Homes, it was concluded that Hampshire Highways would take on responsibility for maintaining the culvert when the bell mouth and access road was adopted by HCC. This was on the basis that access could be gained to both ends of the 525mm pipes to facilitate maintenance. However, it was now apparent that there was no access to the chamber between the 900mm pipe and the 525mm pipes and this created a huge potential for blockages. Hampshire Highways would not be able to maintain the culvert in its current state.

ACTION: VW agreed to contact Linden Homes to request that access is opened up to

the currently inaccessible end of the 525mm pipes.

ii) Outfall from SANGS on Linden Homes site to Crow Lane Ditch

NFDC had received proposals from Linden Homes for the installation of a flap valve and grating on the SANGS culvert pipes. It was agreed that a non-return flap valve was required on the western end of the pipe leading into the Crow Ditch. This would allow the water in the



pond to infiltrate rather than flow into the ditch, thereby prolonging flooding events. It was not clear why grating was required and this was not supported.

It was evident from photographs taken by PS on 7 December that the Crow Ditch is full even before a flooding event. Without the installation of the non-return flap valve, when the flood recedes the water coming off the Linden Homes site would take priority over water coming down the ditch from the north, meaning that flooding in the area of the Elm Tree would take longer to recede.

The same photographic evidence showed the extent of flooding across the upper SANGS area, and both ponds full of water. This supported the installation of a flap valve in the location recommended by Linden Homes

There was concern that the natural infiltration of the ground had been compromised during the construction process (with soil having been removed, material dumped and cleared with heavy vehicles running over the clay pan). VW said that if the state of the field had changed and it was unable to infiltrate at the rate agreed through the planning process, this could potentially be a breach of the original planning permission.

ACTION:

JH to respond to NFDC requesting that an additional non-return flap valve be included in the Linden Homes proposal, and that the grating be removed. Also to raise concern about the infiltration rate of the upper SANGS area having been compromised.

5. Crow Stream

i) Installation of non-return flap valve in the area of Crow wetland to prevent backflow from Crow Stream

Hampshire Highways had previously recommended and agreed to the installation of a "tidal flap to prevent back surge from the faster flowing adjacent river", as part of the scheme to bring the Moortown Lane Flood Relief Drain back into use. However, despite there being funding available (from developers' contributions), no progress had been made. Andy Harding (Hampshire Highways) had expressed his concern about the ongoing future maintenance liability, the need to gain permission from the Environment Agency, and the ability to identify a design resource. He had confirmed that the Moortown Lane system was ready to be brought back in to use, but the consensus was that this could not be done before the flap valve had been installed.

MT said there was a need to resolve all the issues and to progress this scheme without delay, and asked that Andy Harding contact him to discuss how this could be achieved.

Cllr O'Reilly joined the meeting at 10.50am.

In terms of the ongoing maintenance, PS had previously offered his and other volunteers assistance with this. In addition, JH said that the Town Council could check that the flap valve was clear of debris in advance of any expected heavy rainfall, under the Parish Lengthsman Scheme.



ACTION: VW agreed to contact Andy Harding to ascertain the current situation with

regards to this scheme, in order to move it forward and bring it to a

conclusion.

ii) Clearance of Rod Lane Flood Relief Drain

It was noted that about a third of the ditch had been cleared recently (as a result of a job raised 18 months ago) and that the remaining two thirds still required attention. As a result, Rod Lane had flooded at the point where the maintenance had stopped. The ditch had been dug too deep, when all that was required was flailing and the removal of all cuttings and debris. LH confirmed that he had raised a remedial job for the remainder of the ditch to be flailed, although he could not confirm a timescale for this.

ACTION: LH to ensure this work is carried out as soon as possible.

iii) Collapsing gabion at Molly Barnes Corner

LH confirmed that an order had been issued for the damaged section of the gabion to be repaired. There was no timescale for this as it was a specialised job.

ACTION: LH to ensure this work is carried out as soon as possible.

6. Crow Hill Drainage

The collapsed ditch at the bottom of Crow Hill had been referred to HCC's Flood and Water Management Team, who had agreed to contact the landowner to request that it be cleared.

VW reported that Wrightway Farming were the riparian owners and had agreed to clear the ditch by 20 December 2018.

LH handed over 3 roadside markers to PS, who agreed to install these on completion of the clearance works.

ACTION: PS to install roadside markers after the ditch has been cleared to prevent

future overrunning of the verge.

7. Moortown Lane Flood Relief Drain

(Also see 5(i) above).

PS asked whether the whole of the system had been surveyed, and in particular the section from Long Lane to Hampshire Hatches. He was concerned that a previously identified blockage may not have been cleared.

ACTION: LH to check the extent of the survey.

The meeting concluded at 11.30am.

PLANNING, TOWN & ENVIRONMENT COMMITTEE – 4 JANUARY 2019 HAMPSHIRE COUNTY COUNCIL RIGHTS OF WAY CUTTING LIST

- 1. Hampshire County Council is in the process of reviewing its Rights of Way Vegetation Priority Cutting List. The Town Council has been given the opportunity to review the list for Ringwood and suggest any alterations for the 2019 programme.
- 2. This time last year, the Town Council requested that the following 9 paths be included in the 2018 programme. All these paths have been included, and were scheduled for cutting in June.
 - 15 Narrow Lane
 - 37 Hightown Hill to Crow Hill
 - 40 Forestlake Avenue east
 - 41a Forestlake Avenue to Crow (south of Hightown Lake)
 - 42 Hightown Lane to Crow Hill
 - 53 Christchurch Road to end of Hampshire Hatches Lane
 - 54 End of Hampshire Hatches Lane to south of sewage works
 - 82 Green Lane east (south of Upper Kingston Farm)
 - 83 Green Lane to Crow (south of Hightown Lake)
- 3. An additional 4 paths are also included, all of which are on the route of the Avon Valley Path. These were scheduled for cutting in May.
 - 55 Bickerley Road to Hampshire Hatches
 - 69 Hampshire Hatches to B3347 at Kingston
 - 71 Hurst Road to Headlands Business Park
 - 73 Woottons Ford Lane to B3347 (St Paul's Church, Bisterne)

- 4. This year, as was the case last year, we are being asked to reduce the number of paths to 5; to list the paths in priority order; and to add comments to explain why one path should be cut over another, for example if it is used as a route to school.
- 5. As is normal practice, the Ringwood and Fordingbridge Footpath Society has been consulted on the proposals. The Society is concerned about the proposal to reduce the number of paths to be cut to 5, particularly for a parish the size of Ringwood, which has 86 Rights of Way in total. The Society's recommendation with regard to prioritising the paths is as follows:
 - ¿ The four paths listed in paragraph 3 above are part of the Avon Valley Path (AVP), and should be kept clear by Hampshire County Council in any event.
 - 53 and 54 provide an essential alternative route to the AVP when 55 is impassable, as it often is.
 - ¿ The other paths should be prioritised in this order:
 - ❖ 37 a well used path, particularly as 38 cannot be used at present.
 - ❖ 40 a well used path.

- ❖ 82 and 83 well used paths, and likely to be more so with the new houses at Crow Lane/Crow Arch Lane.
- ❖ 41a a well used path.
- ❖ 15 a well used bridleway.
- ¿ The Society advises that Footpath 42 will not be cut by HCC in its present state. It is hoped that the Town Council can work with the Footpath Society in 2019 to clear the southern end of this footpath (where it connects with Crow Hill) by removing some small trees and shrubs currently encroaching on the path.
- 6. Members are asked to consider approving the Footpath Society's recommendations as outlined in paragraph 5, proposing that all paths should remain on the cutting list, particularly as they are relatively short sections and only a very small proportion of the total number of paths in Ringwood.

PLANNING, TOWN & ENVIRONMENT COMMITTEE – 4 JANUARY 2019 COMMITTEE MEETING DATE IN MAY 2019

- 1. In line with the existing schedule of meetings, the date for the meeting of this Committee in May 2019 falls on Friday 3rd May, which is the day after the Quadrennial Elections on 2nd May.
- 3. Apart from the Mayor and Deputy Mayor, councillors retire together on the fourth day after the elections, and on the same day the newly elected councillors come into office. Effectively, this means that all current members of the Committee will still hold the office of councillor on 3rd May when the meeting is scheduled to take place, even if they have not stood for election or been elected.
- 4. It would therefore be possible to go ahead with the meeting on 3rd May as planned. That being said, councillors may not feel comfortable attending a meeting the day after the elections, particularly if they have not stood for re-election.
- 5. As the Council is required to submit observations on planning applications within a specific timescale, it will not be possible to simply cancel the meeting scheduled for 3rd May, as that will leave 9 weeks between meetings scheduled for 5th April and 7th June. There is usually a maximum of 5 weeks between meetings, and even then sometimes observations have to be agreed by the Chairman and Vice-Chairman of the Committee (under delegated powers) and submitted prior to the next meeting of the Committee.
- 6. It is therefore recommended that the meeting scheduled for 3rd May be brought forward to Friday 26th April. It is noted that this is only 3 weeks after the meeting scheduled for 5th April, and that there will then be a 6 week period prior to the next meeting on 7th June. However, it is suggested that, even so, Members may feel more comfortable meeting before the election rather than after it or delaying matters to an early meeting of the new Committee (which will be appointed on 15th May at the Annual Meeting).
- 7. **RECOMMENDED**: That the meeting of the Planning, Town & Environment Committee scheduled for Friday 3rd May 2019 be brought forward to Friday 26th April 2019.


1. Following an approach from The Cellar (5/7 Christchurch Road), the Town Clerk asked New Forest District Council if it would be possible to refurbish the Christchurch Road street sign, which is positioned on the wall above The Cellar. The existing sign, shown below, is in poor condition, discoloured and difficult to read.



2. The response from NFDC is that they do not engage in high level signage, and therefore propose to leave the existing sign where it is and install a more visible sign at street level in the approximate position shown below; their primary concern being that every road has clear and visible signage to assist emergency vehicles, delivery vehicles and other road users in finding their destination. The proposed sign would also be safer to maintain.



3. The proposed sign would include the NFDC logo on the left, Christchurch Road and a directional arrow pointing to the right, as shown below.
