Committee Budget 2026/2027- version one

1. Introduction and reason for report

- 1.1. Members are asked to consider the draft 2026/2027 budget for this Committee and to make recommendations to the Policy and Finance Committee.
- 1.2. This report aims to show how the proposed 2026/27 budget reflects agreed priorities in the Town Council Strategy and supports the delivery of ongoing services and planned projects.
- 1.3. The internal auditor has advised that the Council should continue to improve its level of reserves. Members may wish to keep this in mind when considering the budget and any proposed transfers.
- 1.4. It is too early at this stage to give an accurate indication of what overall percentage change this draft budget might represent compared with the current year. Staffing costs, utility prices and project funding decisions are still being finalised, and these will affect the overall position once confirmed.

2. Strategic Context and Planned Projects

- 2.1. The Town Council's Strategy 2026–2029 identifies several new projects relevant to this Committee, alongside "business as usual" activity. The draft budget has been prepared to ensure the committee can continue core operations while beginning preparatory work on these strategic priorities.
 - 2.1.1. Bus Shelter Improvement Action Plan work continues on delivery of this plan. We are awaiting the outcome of a bid to NFDC for CIL funds for one new bus shelter and will be looking to apply for funds from HCC's new Parish Council Bus Shelter Grant, so there should be no impact on the 2026/27 revenue budget.
 - 2.1.2. Thriving Market Place it is expected this project will be funded from NFDC's Strategic CIL fund; we await the outcome of a Cabinet decision in February 2026.
- 2.2. It should also be noted that we are awaiting the outcome of a bid to NFDC for CIL funds for speed indicator devices, although this will have no impact on the 2026/27 revenue budget.

3. Budget Overview

3.1. Each individual budget area has been reviewed. Where possible, costs have been contained and some budgets have been adjusted to reflect actual figures.

B

- 3.2. The draft budget seeks to limit the impact of any new services or projects on overall expenditure.
- 3.3. Some budget lines have been removed, combined or reorganised to make them easier to manage.
- 3.4. At this stage, no changes are proposed that would require an increase in the overall precept, but this will be reviewed once final salary figures and project funding details are confirmed.

4. Next Steps

4.1. This report presents a first draft of the 2026/2027 budget for this Committee. Figures remain provisional and will be updated once final costs, quotations and pay adjustments are known. Feedback from members will inform the next version before it is submitted to the Policy and Finance Committee.

Recommendations:

- 1. That members note the draft Committee budget for 2026/2027.
- 2. That members provide direction on any changes, priorities or areas for further exploration before the next draft is produced.
