#### P/6518 STRATEGIC SITES

<u>Land off Crow Lane / Crow Arch Lane (Beaumont Park)</u> – Clearance work has been carried out by Round Table, RACE and councillors, on the section of Castleman Trailway between the old railway bridge and Crow Lane. Half of this section has still to be formally adopted by HCC and an update is awaited on this.

Thanks were extended to the Grounds Manager for his help with this and all of the volunteers who turned out to help.

In relation to the application for removal of condition an extension of time has been agreed until 2 February 2026 to allow for completion of the legal agreement, before the formal decision can be issued.

<u>Land north of Hightown Road (21/10042)</u> – no update.

#### Land off Moortown Lane (21/11723 and Land off Crow Lane 23/10707) -

New documents have been added to the planning portal relating to pre-commencement conditions. The Deputy Town Clerk was asked to look into whether improvements to Moortown Lane were included. The CIL liability notice has also been added.

#### **NEW FOREST NATIONAL PARK LOCAL PLAN REVIEW - CONSULTATION**

Members considered the Deputy Town Clerk's report (*Annex C*). It was noted that no sites for development have been proposed in the parish of Ringwood. It was agreed to make no further representation.

## P/6520 PROPOSED EXTENSION TO PUBLIC SPACES PROTECTION ORDERS

Members considered whether to respond to NFDC's consultation on Public Space Protection Order(s) (PSPOs), which proposed to extend both Orders, for BBQs and Wildfires, and Feeding and Petting of Pones, Horses, Mules and Donkeys, for a further 3 years until 2029.

**RESOLVED:** That a response be submitted to the consultation in support of the proposed extension and to there being sufficient awareness and signage advising of the PSPOs.

**PROJECTS** (current and proposed)

**Bids to NFDC for CIL funds** – both bids (for replacement bus shelter in Gorley Road and speed indicator devices (SIDs)) have been approved by NFDC Cabinet. There is a statutory 7-day call in period, when the decision may be subject to review. Outcome letters are expected to be issued on 15 December.

The joint application (with Ellingham, Harbridge and Ibsley Parish Council) for SIDs will be brought back before the Committee with details of how this will work in practice. The Deputy Town Clerk will liaise with Cllr Haywood regarding this and once it is known what is feasible logistically, there will be some consultation on appropriate locations.

**Thriving Market Place** – HCC Engineering team is now working with NFDC's consultants on technical detail, working up a costed and deliverable scheme. Allocation of CIL funding for the scheme is not likely to be considered by NFDC Cabinet before April 2026. Funding has been confirmed by NFDC for the information boards and statue for the Charter Market anniversary celebrations.

**Crow Lane Footpath** – HCC is working on detailed design for the new footpath to link Beaumont Park with Hightown Road, alongside the west of Crow Lane, with a view to work starting in Spring 2026.

**RESOLVED:** That the update on projects (*Annex C*) be received.

## **Climate Adaptation**

# Community-led Climate Adaptation – our future programme to help your community become resilient to climate change

When people talk about climate change, they often focus on how to stop it by taking actions that produce less carbon – for example, switching from petrol cars to electric vehicles, using public transport, reducing energy use, or installing solar panels on your roof. This is called **mitigation**.

But there's another very important part: **adaptation**. That means learning how to live with the changes in our climate that are already happening. In the UK, we're already seeing more extreme weather, like heatwaves and floods. So, we need to get ready for a different kind of future.

Adapting to a different climate is not new. In television nature shows—like those by David Attenborough—we have seen how animals adapt to new environments. For example, in the UK, some birds have changed their migration patterns due to milder winters, choosing to stay in Britain year-round instead of flying south, and even changing their diet to adapt to garden feeders and new food sources. People have always adapted too. The difference now is that the speed of change in our climate is increasing. We need to act quickly to keep our communities safe and strong.

Sadly, the people who are most affected by climate change impacts are often those who have the least—less money, poorer health, or fewer resources. We are also seeing an increase in climate anxiety because people are really worried about climate change. They see the risk to their communities and families from a rapidly changing climate and feel powerless to take decisions or actions that will keep them safer.





How can developments in the science help us?

The Met Office have been modelling the likely changes to climate in the UK and can provide projections from available information for 10, 30, or even 50 years. This gives us the likely changes in heat, rainfall, or other weather-related information. (This information is similar to the weather reports we already use on our Weather App on mobile phones i.e. where we see '<5% chance of rain tomorrow'), but further ahead in time. This new information from the Met Office enables us to establish the level or percentage of 'risk' to our communities and provides data at the level of granularity individual communities can work with.

## What needs to happen?

The provision of weather-related climate risk information is only one part of the solution to help us to adapt effectively. We also need to understand what those new weather patterns will mean for our communities. This information can then be delivered in a useful and practical way. It will help decision-makers across national, local and community levels to take timely and appropriate action as well as providing residents in communities with a clear understanding of what is possible and what they themselves can achieve.

That's where **The Greening Campaign** comes in. We're working with the Met Office and many other partners to develop a community Adaptation Resource to empower local people and local experts to help their own communities prepare for the future. We're here to listen, learn, and support.

## What We're Doing

We are creating a programme to help and support communities:



## Look at the past

How has your area been affected by things like floods or heatwaves? What's happened to homes, businesses, and people? By identifying the real impacts of extreme weather events we can work out the indirect (often hidden and

personal) impacts as well as the immediate direct impact. Communities have the insight and power to gather this information at a local level, engaging local voices that will influence, inform and support better decision making at a local, regional and national level. The community will also decide whose voice is important – the older members, the vulnerable, those less able, local business, etc – not just the decision makers voices or big business. When groups of communities undertake this process it can lead to an understanding of the true effect of weather impacts across a wider area, giving councils and government the information they need to act.



#### Plan for the future

With help from the Met Office, we will look at what weather impacts the changing climate might bring in the future using data at a more granular scale to allow for community microclimates. Using the stories from the past, we will better understand how future traumatic climate events could cause disruption across the community. Met Office multi-sector stakeholder workshops will then support the identification of potential intervention points where action and changes now, or in the near future, can reduce the long-term effect that a changing climate has on people's lives and homes.



## We Will Support You to Take local action

Every community is different. We will help you figure out what works best for your area, using your local knowledge, skills, and resources. Once we have listened to past experience and mapped the likely impacts for the future, the community can produce a very simple, focused report and action plan using our template. This will provide information for the residents of that community

which identifies actions for households; action at community level; at Parish of Town level; at Borough level; at County and above – often working together.

For the Greening Campaign, the important role of the community is to make sure that everyone's voice matters, and everyone has a voice in planning for a better, safer future for their own community.

## Here are some examples of local actions:

Setting up **cool spaces** or shaded areas for vulnerable people during heatwaves.

Understanding the **types of trees** that will flourish in the future so you plant trees that can live in a new climate – we need to plant now to retain the recognised veteran tree lined streets and woodlands we all love.

Identifying older **homes in the community** that due to the building materials used will not tolerate the expansion and contraction of extreme heat and extreme wet. How to protect them from disintegrating. Insects that damage buildings are also likely to increase and we need to understand what that means.

Planting **trees along roads** to reduce heat island effect – where tarmac heats up during a very hot day and acts like a radiator when you try and sleep at night so your core cannot cool down which is necessary to prevent heat exhaustion.

Setting up **community energy projects** to reduce risks of mass power cuts in storms and flooding, and maximise the energy reaching homes in hot weather.

Planning to **change working hours** so outdoor workers are not exposed to extreme temperatures in the middle of the day – what are the ramifications of these changes eg open gardens closing for 3 hours in the day?

Understanding and preparing for **new disease** and new insects that carry it like mosquitos and ticks. How do we keep ourselves safe?

**Work together**: We will connect people at all levels—local, town, and county—to make sure efforts are joined up and effective.

#### REPORT - Planning, Town & Environment Committee - 5 December 2025

#### **New Forest National Park Local Plan Review - Consultation**

#### 1. Introduction

- 1.1. Earlier in the year, NFNPA consulted on its Strategic Direction of Travel to seek views on the scope of the Local Plan Review, together with a Call for sites exercise. Since then, a series of technical evidence reports have been commissioned, these together with early feedback have been taken into consideration in the preparation of an initial full draft Local Plan for consultation. Full details can be viewed here: <a href="Have Your Say Today New Forest National Park Authority Local Plan Commonplace">Have Your Say Today New Forest National Park Authority Local Plan Commonplace</a>
- 1.2. The draft Local Plan includes a revised vision and a set of strategic objectives, supported by a series of policies to guide the type and location of new development within the National Park to help to deliver the statutory National Park purposes and related socio-economic duty. The draft Local Plan also includes proposed new site allocations for residential and employment uses.
- 1.3. Views are now invited on the draft policies and proposals, with a deadline for comments of 19 December 2025.

#### 2. RTC Response

- 2.1. The Committee considered and responded to the previous consultation in March 2025 (<u>P/6514 refers</u>), and commented as follow:
  - 2.1.1. Climate Change "Policies should include greater reference to the design and construction of any buildings (and extensions to the same) to ensure that they are insofar as possible carbon neutral and demonstrate high levels of energy efficiency. This should include a policy that encourages electric car charging points for example."

#### The proposed policies in this respect are:

#### **Policy SP9: Sustainable Construction**

The Authority will support proposals for development that mitigate and adapt to the impacts of climate change. To do this all development should seek to do the following:

- a) Incorporate energy and water efficiency measures appropriate to the building:
- b) Consider 'small-scale' renewable sources (such as biomass and solar) that respond sensitively to the character of the local area;
- c) Use locally and/or sustainably sourced materials within the design and construction of the development;
- d) Minimise the loss of existing native planting and nature features;
- e) Consider how the layout and orientation of the development can take advantage of solar gain;
- f) Avoid development in places at highest risk of flooding/coastal erosion; and



g) Include bird bricks across new residential development, including extensions (minimum two per dwelling).

#### Policy SP10: Renewable energy

Development proposals for, or incorporating, renewable energy generation, other than wind energy, will be permitted where they:

- a) are small-scale and provide energy for individual households or businesses, or for small local community facilities; and
- b) are located and designed to have minimal visual impact ground mounted solar arrays for example should be located within the curtilage of the property; and
- c) do not have adverse impact on the landscape character, heritage assets, natural beauty, wildlife, tranquillity or other special qualities of the National Park.

Planning permission for renewable energy developments likely to have an adverse effect on a designated nature conservation site (including international nature conservation sites, Sites of Special Scientific Interest and National Nature Reserves) will not be granted

2.1.2. **Meeting Housing Needs** – "RTC does not consider it appropriate to comment other than to assert we do not consider that any area within the Parish should be included."

There are no sites proposed in the parish of Ringwood in the draft Local Plan.
