### C/6425 PUBLIC PARTICIPATION

Representatives from AFC Bournemouth Community Sports Trust and Ringwood Town Football Club were in attendance to speak on agenda item 7 – Long Lane Sports Ground Improvement Project. There were no other members of public present.

### C/6426 APOLOGIES FOR ABSENCE

All members were present.

# C/6427 DECLARATIONS OF INTEREST

There were none declared at this time.

### C/6428 LONG LANE SPORTS GROUND IMPROVEMENT PROJECT

Members received a presentation on a potential ground-sharing partnership arrangement from representatives of AFC Bournemouth Community Sports Trust and Ringwood Town Football Club (*Annex A*), and considered the Town Clerk's report (*Annex B*).

Such an arrangement would meet the Trust's need for a permanent base and allow the Club to grow and improve facilities, as well as benefitting the local community.

Proposals were in very general terms as the Trust was looking for the Town Council's support before committing thousands of pounds on detailed investigation and planning work to take the project forward.

Members agreed that this was an exciting project and there was a clear need for improvements, for the Club to grow, and to make best use of the site.

Cllr Heron fully supported the project but cautioned that there was a need to safeguard what was one of the Council's most significant assets for the people of Ringwood. The facility was already heavily subsidised by residents and he was concerned that this should not extend to residents from other areas, bearing in mind that the Trust's main area of operation was currently Bournemouth and Poole.

There was some concern at the proposal for rent to be broadly similar to that currently charged to the Club. It was acknowledged that there would be a benefit to the community, but also that the Trust and Club would benefit from better facilities, improved income streams and savings made elsewhere. However, it was also clear that fees needed to continue to be affordable for local people to participate. It was therefore agreed that rent should be set to accurately reflect the community benefit to Ringwood residents.

With regards to the term of the lease, it was felt that further work was required to establish the exact number of years, however Members agreed that a long lease should be offered.

Members voted on the recommendations in the Town Clerk's report, which were unanimously agreed with amendments to the wording of 3.2, 3,3 and 3.4.

### **RESOLVED**:

- That the Council declares its support in principle for the football facilities at its Long Lane Sports Ground to be shared by Ringwood Town Football Club and AFC Bournemouth Community Sports Trust;
- That the Council declares its willingness in principle to replace the current lease in favour of Ringwood Town Football Club with a new long lease granted to AFC Bournemouth Community Sports Trust for a term to be agreed;
- That the Council declares its willingness to include in such replacement lease all the land in the ownership of the Town Council at Long Lane, with the exception of the Upper Kingston Allotments; and
- 4) That the rent charged under the new lease will be set to accurately reflect the community benefit delivered to Ringwood residents.

### C/6434 COMMUNICATIONS TO BE RECEIVED

The Town Mayor reported the following:

- 1) He was sad to note the resignation of Christine Ford, who had been a considerable asset to the Council. He proposed that a formal presentation to recognise her 21 years of service take place at the Annual Town Assembly in May. An election will now take place to fill the vacancy in the North Ward.
- 2) He had attended a meeting of the Crow Hill Residents Association, at which members were very supportive of a Neighbourhood Plan.
- 3) He had attended a meeting with Wessex Water to discuss the impact of new development on sewerage infrastructure. He would also be meeting with NFDC's Chief Planning Officer to discuss proposed development of the strategic site north of Hightown Road.
- 4) The tree planting at Poulner Lakes organised by RACE had been a great success.

### C/6435 REPORTS FROM TOWN COUNCILLORS AND STUDENT ADVISORS

<u>Cllr Day</u> – had attended a fascinating talk in the Meeting House, organised by Ringwood Society on the subject of listed buildings in the town. He encouraged everyone to attend the exhibition, which would run until 20<sup>th</sup> March. He had attended the tree planting at Poulner Lakes, for which there had been a great turnout, including many young children. 424 trees had been planted. Another session had been arranged for 7<sup>th</sup> March from 12 noon.

<u>Cllr Turner</u> – raised the issue of recent catapult damage by wheel nuts through car windscreens. This had been reported to the Police, but the case had been closed. She encouraged everyone to ensure that all such incidents are reported to the Police.

<u>Cllr Frederick</u> – had attended a meeting of Ringwood Society, whose members believed a Neighbourhood Plan was a "done deal". It had been clarified that the Council had agreed to move forward with the process, but at this stage no decision had been made about the scope of such a plan and there would be a need for widespread consultation. The process will inevitably take a long time to come to fruition and will in due course require a series of resolutions to be put before the Council.

She had been contacted by a local business owner who was prepared to pay to reserve a table at the VE Day event and suggested the Events Team might like to consider this. Cllr Day confirmed an area would be reserved for those less able, but it was difficult to see how the team could manage reserved tables on the day.

<u>Cllr Deboos</u> – expressed his concern about the closure of the post office in the town centre. It was noted that McColl's had given up the main lease of the premises and therefore the Post Office would have to move out when the shop closes in September. There was no confirmation that the Post Office was seeking alternative premises.

<u>Cllr OReilly</u> – had attended the meeting with Wessex Water who reported that Phase 1 (installation of holding tanks) had been successful in that it had prevented internal flooding of properties. Phases 2 and 3 were still to be delivered, although they were unable to provide any detail on what those phases would involve. She also commented that more car parking was required in town, as people were having difficulty finding spaces at times.

### C/6436 REPORTS FROM COUNTY AND DISTRICT COUNCILLORS

<u>District Councillor Rippon-Swaine</u> commented on the Boundary Commission's review, which included proposals to reduce the number of district councillors. The first draft of these proposals was expected in May and, after further public consultation, the review would conclude in the Autumn and the changes enacted in time for elections in 2023.

<u>District Councillor Heron</u> reported that NFDC had now set the Council Tax for 2020/21. Based on a band D property, it would be £178.36 a year, an increase of £5 or 2.88%.

County Councillor Thierry was not in attendance, but had prepared a written report (Annex C).

### Report on Long Lane sports ground improvement project

- 1. Introduction and reason why decision required
  - 1.1 The Long Lane Sports Development and Football Club Working Party met on 6<sup>th</sup> February to consider a report on the improvement project and a presentation from AFC Bournemouth Community Sports Trust. The draft notes of that meeting are attached (Annex A).
  - 1.2 The Working Party members considered that the proposal made by the Trust and supported by Ringwood Town Football Club (RTFC) was of such importance and the need to arrive at a decision in principle whether or not to support it so pressing that it should be brought before the full Council at the earliest opportunity.
- 2. <u>Background information, options, impact assessment and risks</u>
  - 2.1 Steve Cuss and Andrew Battison of AFC Bournemouth Community Sports Trust intend to attend the meeting, make a presentation and answer questions. Phil King and Chris Till of RTFC will also attend and be available to answer questions.
- 3. Issues for decision and any recommendations

Whether the Council should:

- 3.1 Declare its support in principle for the football facilities at its Long Lane Sports Ground to be shared by RTFC and AFC Bournemouth Community Sports Trust;
- 3.2 Declare its willingness in principle to replace the current lease in favour of RTFC with a new lease granted to AFC Bournemouth Community Sports Trust for a term of at least 25 years;
- 3.3 Declare its willingness to include in such replacement lease all the land included in the current lease and at least that portion of Bernie Guy's field that is currently used for football; and
- 3.4 Agree that the rent charged under the new lease will be broadly similar to that currently charged to RTFC.

### 1. Election of chairman

Cllr. Briers was proposed by Cllr Ring and seconded by Cllr Haywood. There were no other nominations.

# Cllr. Briers was duly elected chairman of the Working Party until the first meeting after the next annual meeting of the Council.

### 2. Apologies for absence

There were none.

### 3. Declarations of interest

It was noted that Cllr Briers is an allotment holder at Long Lane and Cllr Loose is involved with the football club, therefore, each has a non-pecuniary interest in the matters to be discussed.

### 4. To agree notes of last meeting held on 10<sup>th</sup> September 2018

The notes were agreed as a true record.

### 4. Sports facilities improvements (inc. 3G AGP) project

Members considered the report from the Town Clerk on development of the project since the last meeting (Annex A).

Jamie Burton reported that similar projects have been completed successfully elsewhere in the district but would require the preparation of a Funding Plan, a Usage Plan and a Development Strategy together demonstrating financial and managerial sustainability.

The general conclusion was that the Town Council and Ringwood Town Football Club are unlikely to be able to develop a viable project within the foreseeable future without outside assistance.

### 5. Proposal from AFC Bournemouth Community Sports Trust

Steve Cuss explained the role of his Trust as the charitable community sports arm of AFC Bournemouth. It is closely associated with the premier league club but is legally separate

from it and has no direct involvement with the club's professional teams. He outlined their existing activities and facilities, including the work they already do in Ringwood and the links they have with Ringwood schools and RTFC.

He explained that the Trust is hampered somewhat by their lack of a permanent base and has been talking to RTFC about the possibility of sharing their space at Long Lane. Early discussions have been positive; it appearing that their needs and the needs of RTFC would complement rather than compete with one another. The Trust is used to developing and managing precisely the kinds of new facilities that are needed at Long Lane and has access to sources (and levels) of funding not available to RTFC and/or the Council.

The Town Clerk reported that he had been consulted about these discussions and had arranged this meeting so that members could assess the idea before matters develop further. Steve Cuss explained that further development of a "ground-sharing" partnership arrangement would require a significant investment of resources by the Trust on which they cannot prudently embark without a commitment from the Council as the owner of the site. Specifically, it would be a condition of securing the funding required that the Council grant the Trust (not RTFC) a lease of the site for at least 25 years. The Council would therefore need to commit to that in principle before the project could proceed further.

It was acknowledged that the interests of RTFC and the Rifle Club would need to be protected and the project would have to demonstrate wider public benefits in order to justify the commitment of the public resources involved. The project would also have to take account of factors like the uncertain tenure and future of the "Ten-Acre Field", access to the site, likely future housing development in the town and many other issues of detail. However, members present agreed that there is sufficient merit in the proposal for it to receive further consideration and that in view of its importance and urgency it should be considered as soon as practicable by the full Town Council rather than just the Recreation, Leisure and Open Spaces Committee.

### **RECOMMENDED:**

That the commitment sought by the Trust from the Council be formulated more precisely and brought for consideration to the meeting of the full Town Council scheduled for 26<sup>th</sup> February.

# LONG LANE SPORTS DEVELOPMENT AND FOOTBALL CLUB WORKING PARTY 6<sup>th</sup> February 2019

# Sports Facilities Improvements (inc. 3G AGP) Project

- 1. Introduction and reason for report
  - 1.1 It has been a considerable time since members last received an update on this important project and it is timely that members receive an explanation of the reasons for the delay now that a critical turning point has been reached.

#### 2. Background information and update

- 2.1 A feasibility study was completed in 2018. This Working Party accepted that it provided a basis for further discussion between Council officers and representatives of Ringwood Town Football Club (RTFC). Those discussions have continued since with the aim of working up a more detailed proposal for consideration by both organisations.
- 2.2 A project which this Council could approve would need to meet many criteria. Two of these need particular mention:
  - 2.2.1 Since the capital costs of the improvements would have to be met in part by means of a grant from Football Foundation (FF), the conditions attached to such a grant must be understood and capable of being complied with; and
  - 2.2.2 The stable and robust financial viability of RTFC (as an essential party to long-term land tenure and facility management arrangements) would need to have been demonstrated.
- 2.3 In the course of discussions with FF, it emerged that it requires grant applicants to show how the renewal of the facilities will be funded when they wear out. Specifically in this case, they would require RTFC to transfer £25,000 into a sinking fund every year for ten years to meet this requirement as a condition of receiving the grant needed.
- 2.4 RTFC committee members have carefully and thoroughly researched how the new facilities (especially the 3G AGP) could be used to maximize use and revenue and the effect this would have on its finances. Even taking a reasonably optimistic view of future finances, they can see no possible way of funding so large an annual transfer to a sinking fund for as long as FF would require. Accordingly, they have been forced to conclude that the project as presently conceived is not viable and have advised the Town Clerk accordingly.
- 2.5 Every effort has been made to try to salvage the project. Different combinations of new facilities have been considered, numerous third parties have been approached and consulted, alternative sources of finance have been considered and football clubs elsewhere have been asked how they were able to complete similar projects. All to no avail. The picture that has emerged is that grant-funded improvement schemes of the kind considered so far only now work for clubs significantly larger than RTFC or if, in addition to the football club, there is another major partner (such as a university, college, large school or large sports club) involved who will share use of the facilities in a way that complements rather than conflicts with the football club use and will contribute to the funding requirements. (In our case, Ringwood School considered the site too remote from the school to enable them to use it during the day. The Rugby Club were interested but this was would have required use of a different type of "carpet" which would have prejudiced FF funding and RTFC use.)

- 2.6 The Clerk has since also received indications from Football Association sources that 3G AGP facilities tend to require regular use by about 40 teams to be financially sustainable. This bears out the calculations made by RTFC, which currently runs a little under 30 teams and is, therefore, under the "critical mass" required to go it alone.
- 2.7 However, the need for the new facilities remains as great as ever. RTFC's clubhouse has major dilapidations and the changing facilities for teams and match officials are inadequate. The lack of a full-sized, all-weather playing surface is preventing RTFC from expanding its youth teams and offering more opportunities for girl's and women's football, walking football and so on, as it otherwise could and would like to do. Apart from the Rifle Club, there remains no provision on the site for any sport other than football.
- 2.8 Improving the facilities is essential to the Council's current strategic plan for the site and to the appropriate use of developer contributions collected by NFDC and provisionally allocated to this site. Accordingly, the Council may have little choice but to review and revise its strategy for the site (which could have implications for the allocation of the developer contributions) unless some means can be found of increasing predicted usage of the new facilities.
- 2.9 With this predicament in mind, RTFC has been discussing with a local Community Trust whether their respective needs are compatible and could be met by proceeding with some form of facility-sharing arrangement. The Town Clerk was recently made party to these discussions and desires members to have an opportunity to hear what is being discussed and say if it is worth pursuing further. All parties are keen to work towards clarifying any "red lines" that any such arrangement could not cross if it is to receive the necessary Council support.
